### **Grant Eligibility Criteria:**

The following criteria must be satisfied *prior to application* for a school to be eligible for a grant:

- The school is a Catholic school within the boundaries of the Diocese of Wichita.
- The school is enrolling or planning to enroll student(s) with moderate to significant intellectual / developmental / physical disabilities who would not be able to attend without additional educational support.
- The school has appropriate educational support for the student(s), with a Special Education or Resource teacher on staff or a plan to train, credential and/or license personnel in that position, or is applying for grant funding of such training/credential/license or positions.
- The school can demonstrate the commitment of its Principal and Pastor to inclusive Catholic education.
- FIRE requests the engagement of school and parish communities in inclusion awareness and fundraising endeavors. FIRE partners with schools that are willing to work together to build inclusive learning opportunities and foster a culture of belonging. The school will designate liaisons who will be a point of contact for communication with the school community about events, fundraisers, and general information about FIRE Foundation of Wichita and its mission.
- If the school is a current partner school, having received FIRE Wichita grants in the previous school year, they must show increased expertise and openness to serving additional students with moderate to severe special education needs. They should also demonstrate the intent to increase their special education budget to ensure the success of their inclusion program going forward.

### **Areas Funded:**

- Professional Development related to Inclusive Education
- Learning Materials, Technology and Equipment
- Assistance for faculty/staff or contract salaries such as Paraeducators, Special Education Teachers, Inclusion Coordinators, Reading Specialists, Therapy Services etc.

### **Application Review Process:**

A grant application must satisfy the Grant Eligibility Criteria for the application to be considered. Eligible applicants may be invited to discuss their application in person with representatives from our Board of Directors the week of March 9, 2026. We will offer invitations for interviews on a case by case basis if we feel more information is necessary. This meeting will focus on questions from the grant application directly. Grant awards will be determined based on compliance with the eligibility criteria outlined above, the need for assistance, and the availability of FIRE Foundation of Wichita funds. All grant monies awarded must be used exactly as specified in the grant award letter or returned to FIRE Foundation of Wichita.

Please note that all grant recipients are required to submit a mid-year and end-of-year report documenting use of grant funds. Any changes in the way grant funds are used that deviate from descriptions outlined in the grant award letter must be immediately reported to the board of FIRE Foundation of Wichita *prior* to the funds being spent ([info@firefoundationwichita.org](mailto:info@firefoundationwichita.org)). Mid-year report forms will be sent to grant recipients via e-mail by December 31, 2026 and are due via email by January 15, 2027. End-of-year report forms will be sent to recipients via e-mail by May 1, 2027 and are due via e-mail by June 1, 2027.
